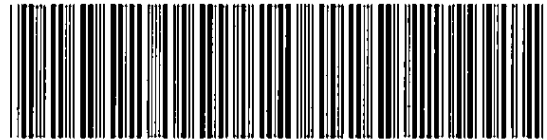

The first paragraph of Article FOURTH is amended and restated in its entirety as follows:

"FOURTH: The total number of shares of all classes of stock which the Corporation shall have authority to issue is (i) Four Million One Hundred Twenty Thousand Six Hundred Nine (4,120,609) shares of Common Stock, \$0.01 par value per share ("Common Stock"); and (ii) One Million Two Hundred Sixty Four Thousand One Hundred Thirty-Six (1,264,136) shares of Preferred Stock, \$0.01 par value per share ("Preferred Stock"). Three Million Eight Hundred Sixty-Two Thousand Six Hundred Nine (3,862,609) shares of Common Stock shall be designated as voting Common Stock ("Voting Common Stock") and Two Hundred Fifty-Eight Thousand (258,000) shares of Common Stock shall be designated as non-voting Common Stock ("Non-Voting Common Stock"). The holders of all capital stock of the Corporation may be referred to herein as "shareholders" or "Shareholders."
