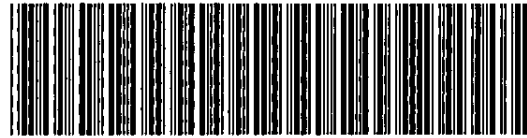


### AMENDMENT
