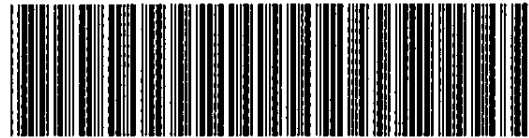

**ARTICLES OF INCORPORATION
OF**

The undersigned incorporator, for purposes of forming a professional service corporation pursuant to the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes (the "Act"), hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is Evangelista Law, P.A. (the "Corporation").

ARTICLE II - ADDRESS

The address of the principal office and the mailing address of the Corporation is: 1395 Brickell Avenue, Suite 501, Miami, Florida 33131.

ARTICLE III - PURPOSE

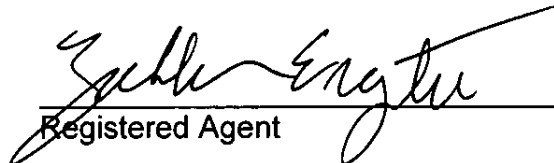
