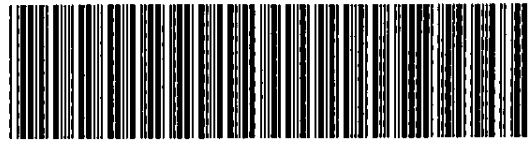

Pursuant to the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, the undersigned incorporator of KB Business Enterprises, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I
NAME AND ADDRESS

The name of this Corporation is KB Business Enterprises, Inc. The street and mailing address of the Corporation is 1600 East 8th Avenue, Suite C-201, Tampa, FL 33605.

ARTICLE II
BUSINESS AND ACTIVITIES

The general nature of the business to be transacted by this Corporation shall be to have and to exercise all powers conferred by the laws of Florida upon profit corporations, and to do any and all things herein set forth to the same extent as a natural person might or could do. The Corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation.

ARTICLE III

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors of this Corporation.

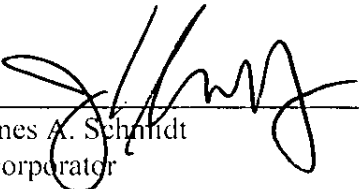
