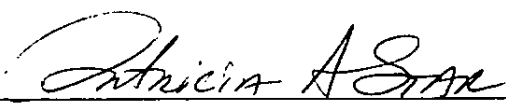
ARTICLE IV - OCCURRENCE RESULTING IN DISSOLUTION
