The Articles of Incorporation for the purpose of forming corporation under the Laws of the of Florida, Chapter 607 and subject to the following provisions:

ARTICLE ONE

The name of the Corporation shall be: MICHELLE RENTALS APARTMENTS, INC

This corporation shall have perpetual existence and may engage in any Activity or business permitted under the laws of the United States of Florida
