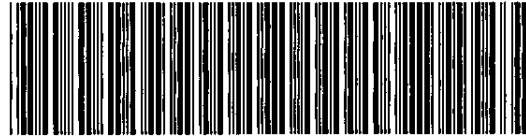

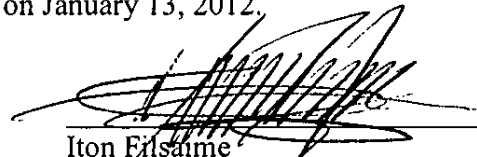

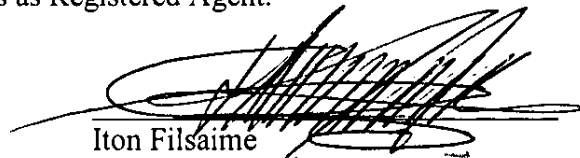
ARTICLE VII AMENDMENTS

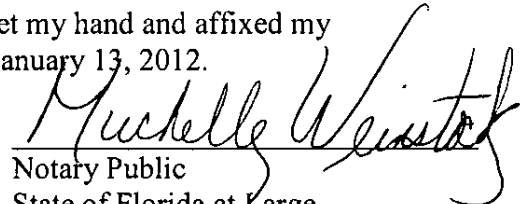
