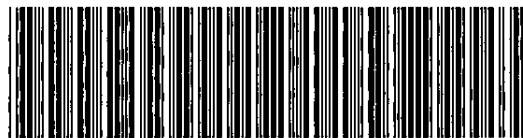

ARTICLES OF INCORPORATION

OF

CAPITAL LAW CENTER, ROBERT W. CARLSON & ASSOCIATES P.A.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME
