ARTICLE 2 - NATURE OF BUSINESS


The Corporation shall engage in any kind of business authorized by the United States laws and the State of Florida.

C.V. 5.4 The Board of Directors of the Corporation may, by articles supplementary, classify or reclassify any un issued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions or redemption of the stocks.


