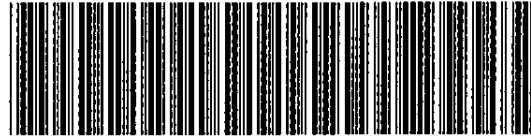

ARTICLE I.
NAME
