ARTICLES OF INCORPORATION

We, the undersigned, do hereby associate ourselves together and subscribe
The Articles of Incorporation for the purpose of forming corporation under the Laws of the State
of Florida, Chapter 607 and subject to the following provisions:

ARTICLE ONE

The name of the Corporation shall be YANAI MEDICAL TRANSPORTATION CORP

This corporation shall have perpetual existence and may engage in any Activity or business permitted under the laws of the United States of Florida.

ARTICLE TWO

The general nature of business to be transacted by this corporation shall Be:

- a) This Corporation is organized for the purpose of engaging in a business Organized Under Florida General Corporation law, Chapter 607, Florida States.
- b) To manufacture, purchase or otherwise acquire, and to own mortgage, Picdge, sell, Assign, transfer or otherwise dispose of, and it invest in, trade in, and deal in and with Goods, wares, merchandise real and personal property, and services of every class, kind And description.

- e) To purchase the corporate assets of any other corporation and engage in the same or Other character of business.
- f) To acquire by purchase subscription or otherwise and to receive, hold, Own, guarantee, Sell, assign, exchange, underwrite, transfer, mortgage, pledge or otherwise dispose of Or deal in and with any of the shares of the capital stock or any Voting trust certificates

ARTICLE THREE

The maximum number of shares of stock, which the corporation shall have
Outstanding at any time, shall be 500 shares of common stock ______\$2.00 par Value, _____

All or any part of the capital stock may be paid for either in lawful monies of the United States of America, or in other assets transferred to the corporation, at ;1 true valuation as of the time of the exchange for stock.

ARTICLE FOUR

The principal office of the corporation shall be located at: 12225 SW 217 STREET MIAMI, FL. 33170 Other offices for the transaction of business may be located wherever the Directors may deem necessary or expedient.

ARTICLE FIVE
