**ARTICLES OF INCORPORATION
OF
ANTHEM PARK HOLDINGS, INC.**

The undersigned, acting as the incorporator of Anthem Park Holdings, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation is: Anthem Park Holdings, Inc.

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS OF THE CORPORATION

The principal business office and mailing address of the corporation is 3434 Colwell Avenue, Suite 120, Tampa, Florida 33614.

ARTICLE III
COMMENCEMENT AND DURATION

The corporation is to commence its corporate existence effective immediately, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE IV
PURPOSE
