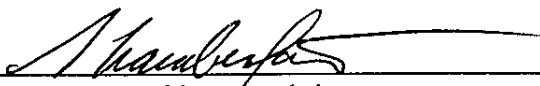
ARTICLES OF INCORPORATION OF

1. Name. The name of the corporation is: STAR HEALTH PLAN, INC.
2. Purpose. The corporation may engage in any legal business.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 100 shares of common capital stock with no par value, of which 60 shares shall be nonvoting.
4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on January 26, 2012.
