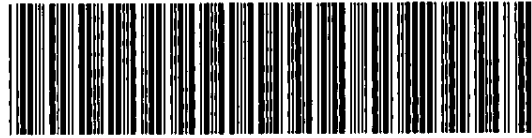

Name**

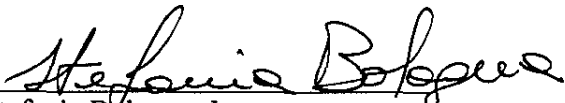
