ARTICLES OF INCORPORATION

SIGRETARY OF STATE TALLAHASSEE, FLORIDA

#### **ARTICLE 1 – Name and Address**

I, the undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, acting as incorporator of a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

#### **ARTICLE II - Duration**

This Corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation.

#### **ARTICLE III - Purpose**

This Corporation is organized for the following purposes:

This corporation will be allowed to practice dentistry for the general public and any and all legal activities in the state of Florida.

#### <u>ARTICLE IV – Capital Stock</u>

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase this pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### **ARTICLE Vil - Initial Registered Office and Agent**

#### <u>ARTICLE VIII – Initial Board of Directors</u>

Board of Directors of this Corporation shall have ONE (1) Director initially. The number of directors may either be increased or diminished from time to time by the by-laws, but shall never be less than ONE (1). The name and address of the initial Director of the Corporation is:

# **ARTICLE X - Indemnification**

This Corporation shall have the power to indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

#### ARTICLE XI - By-Law

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

#### **ARTICLE XII – Restrictions on Transfer of Stock**

The shares of capital stock of this Corporation shall be issued initially to the following person in the amount set opposite her name:

Shares held by the initial shareholders listed above may not be resold or otherwise transferred to another person unless such shares are first offered to the remaining shareholders of the Corporation. #### <u>ARTICLE XIII – Calling Special Meetings</u>

Special meetings of shareholders may be called by written notice, delivered to each shareholder, TEN (10) business days prior to the meeting date.

#### ARTICLE XIV – Shareholder Quorum and Voting

FIFTY-ONE percent (51%) of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of the shareholders. If a quorum is present, the affirmative vote of FIFTY-ONE PERCENT (51%) of shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

#### **ARTICLE XV-Management of Corporation by Directors**

All corporate powers shall be exercise by or under the authority of, and the business affairs of this Corporation shall be managed under the direction of the Board of Directors of this Corporation.

#### **ARTICLE XVI-Removal of Directors**

The shareholders of this Corporation shall not be entitled to remove any director without cause.

#### **ARTICLE XVII-Director Quorum and Voting**
