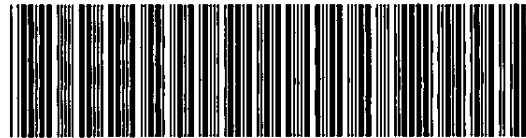

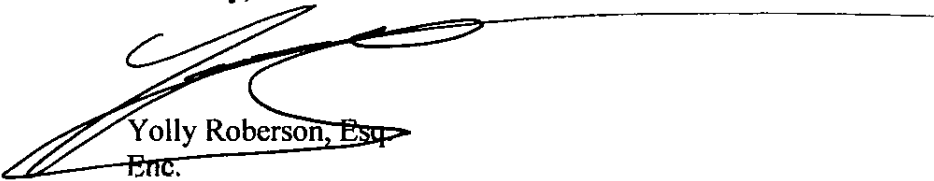

**ARTICLES-OF-INCORPORATION
ROBERSON & ROBERSON, P.A.**

The undersigned Incorporator hereby files these Articles of Incorporation in order to form a Corporation under the laws of the State of Florida.

ARTICLE -I

NAME AND PRINCIPAL OFFICE

The name of this Corporation shall be ROBERSON & ROBERSON, PA.. The principal place of business and mailing address of this Corporation is 900 NE 195th Street, Suite 408, Miami, Florida 33179.

ARTICLE- II

NATURE OF BUSINESS

The Corporation is organized for the purpose of engaging in any or all activity or business permitted under the Florida Professional Services Corporation Act for the rendering of professional legal services and related activities.

ARTICLE-III

STOCK

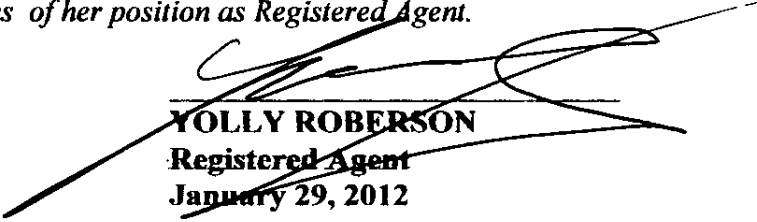
