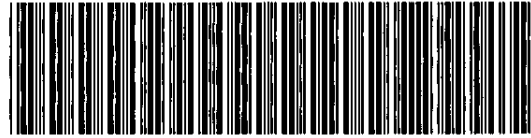

The street address of the initial registered office of the corporation is 2110 SW Fort King Street, Ocala, FL 34474.


