Dear Ms. Roberts:

I represent Tony Caribaltes of Caribaltes Consulting, LLC. Mr. Caribaltes has brought to my attention that FC Staffing, Inc. has filed Electronic Articles of Incorporation with the Florida Secretary of State Division of Corporations and listed Anthony Caribaltes as the Registered Agent. Mr. Caribaltes never agreed to serve as the Registered Agent for FC Staffing, Inc. In addition, you have used his name incorrectly. We also found that FC Staffing, Inc. filed a 2013 Florida Profit Corporation Annual Report on April 5, 2013 and listed Anthony Caribaltes as the Registered Agent.

On February 22, 2013, you provided Mr. Caribaltes with a termination of subcontractor engagement. Therefore, you should remove his name from all documents as a Registered Agent in Florida.

Accordingly, you have used Mr. Caribaltes name and signature without authorization in connection with your filings with the Florida Secretary of State. We request that you immediately file a Notice of Removal and correct your filings with the Secretary of State. We request that you send us written confirmation within fourteen (14) days of the date of this letter that Mr. Caribaltes' name has been eliminated from all FC Staffing, Inc. documents as a Registered Agent in Florida. Thank you for your cooperation in this matter.
