TO ARTICLES OF INCORPORATION OF
GLOBAL TURF EQUIPMENT IC-DISC, INC.**

Pursuant to Sections 607.1001, 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation, **GLOBAL TURF EQUIPMENT IC-DISC, INC.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to amend its Articles of Incorporation:

1. The name of the Corporation is Global Turf Equipment IC-DISC, Inc.
2. Article IV of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue 1,000 shares of common stock, having a par value of \$25.00 per share, which will be designated Common Stock.

3. The Amendment was adopted effective as of February 9, 2012 by the written consent of the shareholders of the Corporation. The number of votes cast for the amendment by the shareholders was sufficient for approval.
