ARTICLE ONE NAME

The name of this Corporation shall be:

FRED ELECTRICAL SUPPLIES, INC.

ARTICLE TWO NATURE OF BUSINESS

IMPORT AND EXPORT OF ELECTRICAL MATERIALS AND SUPPLIES; INDUSTRIAL SECURITY MATERIALS AND RELATED PRODUCTS

ARTICLE THREE TERM OF EXISTENCE

This Corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: FEBRUARY 10, 2012.

ARTICLE FOUR MINIMUM CAPITAL

The amount of capital with which the Corporation shall begin business shall not be less than ONE THOUSAND Dollars, or such greater amount as may be required by law.

ARTICLE FIVE NUMBER OF DIRECTORS

All Directors of this Corporation must be at least eighteen (18) years of age. The stockholders of this Corporation may, from time to time, and at any time, increase or diminish the size of the Board of Directors of this Corporation, provided that the Corporation shall at all times have a minimum of one (1) Director.

ARTICLE SIX

DIRECTORS

The Bylaws of this Corporation may provide that the Directors, after being elected, serve their position until they resign or are replaced. No specific period is stated.

ARTICLE SEVEN **AMENDMENT**

This Certificate of Incorporation may be amended in any manner consistent with the laws of the State of Florida.

ARTICLE EIGHT CAPITAL STOCK

This Corporation is authorized to issue shares of stock as follows:

- Designation: The stock of this Corporation shall be known as Common Stock. Authorized: The maximum number of shares of Common Stock that this Corporation may issue is: 1,000.
- Par Value: Each share of Common Stock shall have the par value of: \$1.00. Shares of Common Stock may be issued in exchange for cash, Consideration: real property, labor of services rendered, or any combination of the foregoing. In the absence of fraud in the transaction, the judgment of the Board of Directors as to the value of any such consideration shall be conclusive.

Non-assessability: Each share of Common Stock shall be issued in exchange for consideration which is at equal to the par value thereof, and shall be fully paid and non-assessable.

Voting Rights: Each share of Common Stock shall entitle the record holder thereof to one (1) vote upon each proposal presented at meetings of the stockholders of the Corporation.

Cumulative Voting: No holder of Common Stock shall be entitled to any right of (g) cumulative holding.

- Dividends: Record holders of Common Stock are entitled to receive their pro-rata (h) share of any dividends that may be declared by the Board of Directors out of assets legally available for such purpose.
- Liquidation Rights: Holders of Common Stock are entitled, in the event of the liquidation or dissolution of this Corporation to receive their pro-rata share of any assets of this Corporation remaining after payment of all corporate debts and obligations.
