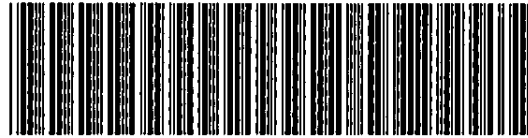

**ARTICLES OF INCORPORATION
OF
Tampa Dental Wellness of Westchase P.A.**

In compliance with the requirements of Florida Statutes Chapter 621 and Chapter 607, the undersigned hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a professional business corporation.

ARTICLE I

The name of the Professional Corporation is: **Tampa Dental Wellness of Westchase P.A.**

ARTICLE II

The existence of the Professional Corporation shall begin on the date of filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE III

The street address of the principal office of the Professional Corporation is: 11321 Countryway Blvd., Tampa, Florida 33626.

The mailing address of the Professional Corporation is: 11321 Countryway Blvd., Tampa, Florida 33626.

ARTICLE IV

The specific purpose for which the Professional Corporation is organized is to engage in every phase and aspect of the business of rendering the same professional services to the public that a dentist, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to practice dentistry.

The professional corporation shall have all the powers conferred upon it by the laws of the State of Florida or of any other State or country and not prohibited by the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, or the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes; provided, however, that this professional corporation shall not engage in any business other than rendering of the professional services described above for which it was organized.

It is expressly hereby provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this professional corporation otherwise permitted by law.

ARTICLE V

The maximum number of shares this Professional Corporation is authorized to issue is 1,000,000, all of which shall be Common Shares. The par value of the shares shall be \$0.00 per share. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI

The initial street address of the Professional Corporation's registered office is: 701 Market Street, Suite 109, St. Augustine, Florida 32095. The initial registered agent for the Professional Corporation at that address is the Law Offices of Curtis & Associates, P.A.

ARTICLE VII

The initial board of directors shall consist of one (1) member. This number may be increased or decreased from time to time in accordance with the Professional Corporation's bylaws, but shall never be less than one. The name and address of the person who will serve as the initial, sole director is Amy Creech-Gionis.
