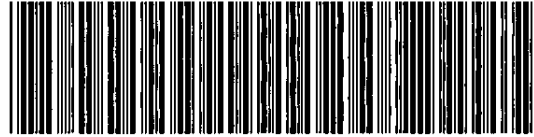

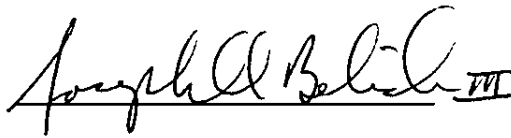
Article X.

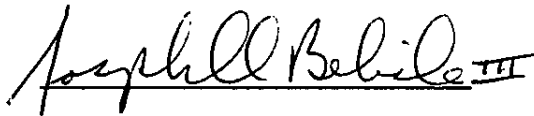
