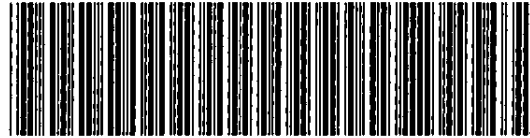

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: JUST SAY NO TO LIPO, INC. The principal place of business will be 26252 Sword Dancer Drive, Wesley Chapel, FL 33544.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

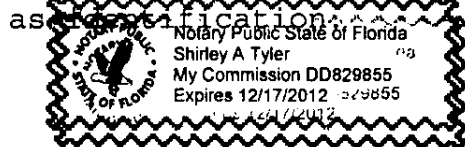


