ARTICLE I



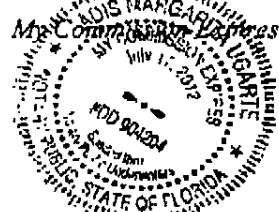
