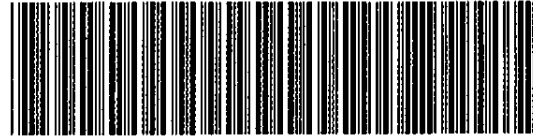

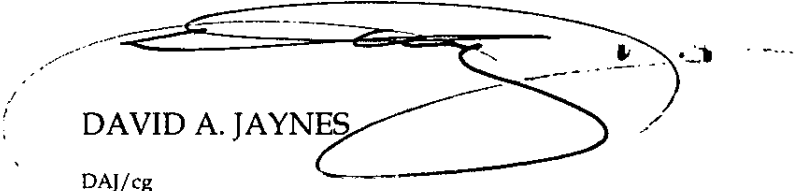

**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is NATIONWIDE MEDICAL RECRUITERS, INC. and its principal place of business shall be located at 116 No. Ridgewood Avenue, Edgewater, FL with mailing address as P.O. Box 992, Sandersville, GA 31082.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

## ARTICLE X - INDEMNIFICATION

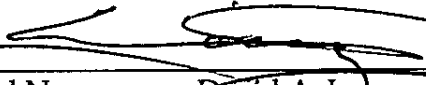
