

In order to allow a new entity to be formed using the name "Weston Insurance Company," we delivered Articles of Dissolution to the Secretary of State for the existing entity (Document Number P11000029880) yesterday, and the entity has now been voluntarily dissolved.

The undersigned incorporators, pursuant to Chapters 607 and 628, Florida Statutes, adopt these Articles of Incorporation of Weston Insurance Company (the "Corporation"), a stock insurer.

**ARTICLE 1**

**Name**

The name of the Corporation is: WESTON INSURANCE COMPANY

**ARTICLE 2**

**Purpose and Existence**

The purpose of the Corporation is to engage in the business of property and casualty insurance and any other activity or business now or hereafter permitted under the laws of the United States and of the State of Florida. The Corporation shall exist perpetually.

**ARTICLE 3**

**Principal Office and Mailing Address**

The address of the Principal Office and the mailing address of the Corporation in Miami-Dade County, Florida is 3150 SW 38<sup>th</sup> Avenue, 10<sup>th</sup> Floor, Miami, FL 33146. The location of the Principal Office and the mailing address shall be subject to change as may be provided in the Bylaws.

**ARTICLE 4**

**Capital Stock**

The total number of shares of capital stock which the Corporation shall have the authority to issue shall be 1,000 shares, all of which shares shall be denominated "Common Stock," having a par value of \$1.00 per share. Pursuant to Section 628.121, Florida Statutes, the Corporation shall maintain capital and surplus in an amount sufficient to comply with Sections 624.407 and 624.408, Florida Statutes, and other applicable provisions of the Florida Insurance Code, as may be amended from time to time.
