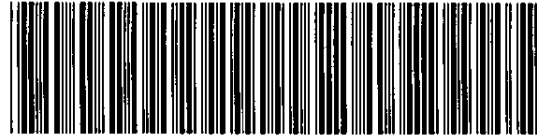

The undersigned persons hereby associate for the purpose of becoming a corporation for profit under the laws of the State of Florida in compliance with Florida Statute §607.0202.

Article I

The name of the corporation shall be **CPOD-2, INC.**

Article II

The mailing address of the principal office of the corporation shall be:

Article III

The purpose for which the corporation is being formed and the general nature of the corporation's business shall be any activity or business permitted under the laws of the State of Florida.

Article IV


