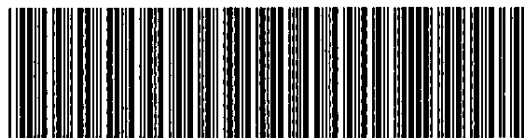

The names of the Incorporators are: Jason Baker - President/Director (50%) and Nicole Rodriguez -Vice-President/Director (50%)


ARTICLE VIII - BEGINNING OF CORPORATE EXISTENCE




