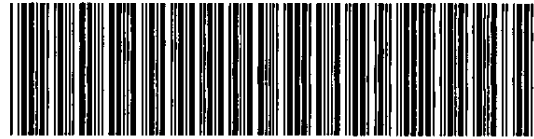

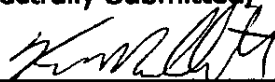

The Initial Officer and Director of the Corporation shall be:

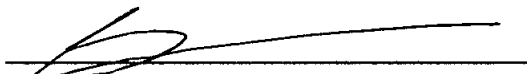

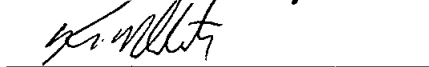
