The undersigned, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, Chapter 607 of the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE 1: NAME AND INITIAL ADDRESS.

The name of this corporation is TRANS-SAHARA TRADING COMPANY, U. S. A., INC. The principal office and initial address is 20 Orisco Avenue, Sahara, Dansoman, Accra, Ghana.

ARTICLE 2: DURATION, TERM OF LIFE, OR TENURE.

The duration, term of life or tenure of the corporation is perpetual.

ARTICLE 3: PURPOSE.

The general purposes for which the corporation is organized are the following:

1. To engage in international trade transactions.
2. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act and other incorporation laws of the State of Florida. No other purpose shall limit this general purpose in any way.
3. To do such other things as are incidental to the purpose of the corporation or necessary or desirable in order to accomplish them.

ARTICLE 4: SHARES AND CLASS OF STOCK.

The aggregate number of shares and class of stock which the corporation is authorized to issue is one thousand shares of common stock. Such shares shall be of common stock class and shall have a par value of \$0.01 per share.

ARTICLE 5: INITIAL REGISTERED OFFICE AND AGENT.

The street address of the initial registered office of the corporation is 67 N. E. 167th Street, North Miami Beach, Florida, and the name of its Registered Agent at that address is Glenn R. Miller, Attorney at Law.

ARTICLE 6: INITIAL BOARD OF DIRECTOR

The number of the Directors constituting the initial Board of Directors is one (1). The number of directors may be increased or decreased from time to time in accordance with the bylaws, but shall never be less than one. The following is the name and address of each director of the corporation:

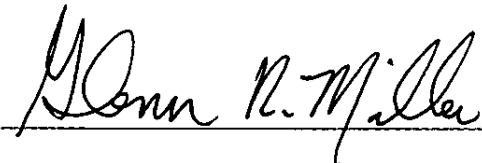
