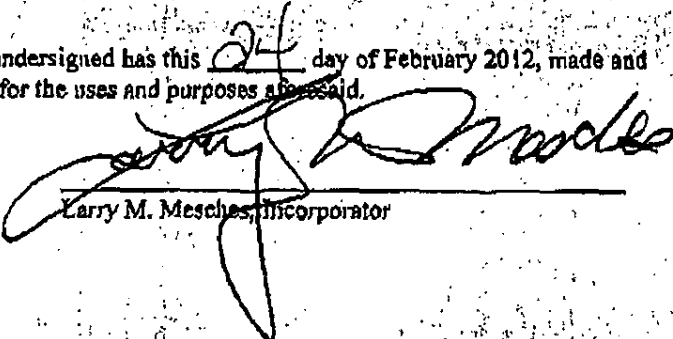
COURAGE TO SMILE, INC.

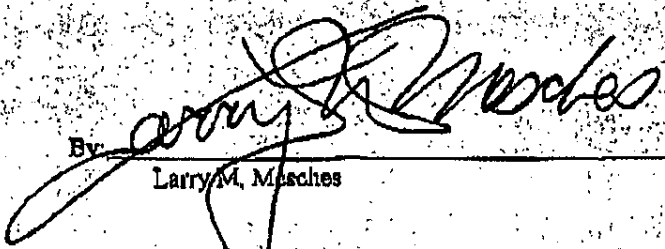

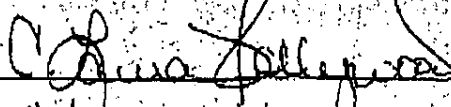
