The Corporate Name chosen in this filing is meant to be a unique group of letters which was selected to represent a sequence of different companies, one that currently exists and additional new ones which are being formed to follow a sequence of web-sites we own and have sole copyrights to.

We chose the letters (ARS-FLA) 17 years ago, to represent the first company which is Analytical Research Systems (ARS), inc. (an active Florida corporation est. in 1995) with its website being "www.ARS-FLA.com" which is still active today, and now with other companies to follow, that would be designated ARS-FLB, ARS-FLC, ARS-FLD, etc... and since ARS alone and ARS1,2,3 etc.. was not available, the "-FLA" was chosen to represent a unique company identity (its own name) and is not meant to mean "FLORIDA", but rather the first in a sequence of companies that we can have registered website domain names that are available in the international internet database registry.

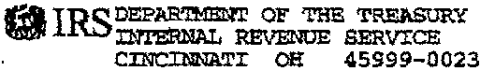
