**ARTICLES OF INCORPORATION  
of  
HILLCREST PROPERTIES IX, INC.**

ARTICLE I - NAME

The name of this corporation is Hillcrest Properties IX, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.


ARTICLE XII - MEETINGS

Meetings of shareholders and directors, including the time, place, and manner of calling such meetings, shall be fixed by the by-laws of the corporation.


ARTICLE XIII - AMENDMENT
