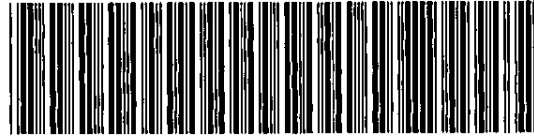


To Whom It May Concern:

My name is Krystal Hall Bowdry. Earlier today I spoke with a member of your staff regarding the Revocation of Only Quality Service by Tony, Inc. that was submitted by a Romona A. Brookins on December 15, 2012 to the State of Florida. I am very troubled that the State allowed this person to file the Revocation without her being an actual designee on record with the State per my registration of the Company on March 8, 2012. I was told today by your staff person that due to the large number of documents that come into your Office, these documents are "just processed". I would like it noted that such a practice has caused & potentially will further cause me and my family great financial and emotional strain since my finding out about this Revocation on Friday, January 18, 2012; thus I should hope that the State put into practice a set of revisions to have a checks & balances system in place to prevent such false Revocations and beyond from being filed.

At this time I am not seeking any Legal action against Ms. Brookins due to my speaking with her for the first time ever on January 22, 2013; however I do want it on record with the FL State Division of Corporations that at no time was Ms. Brookins ever elected or appointed as Director of Only Quality Service by Tony, Inc. and there is no record to the State that she was either. The only parties reflecting at time of my registering the Company and also currently are Lyntonio I. Bowdry, (my spouse), and Krystal H. Bowdry, (me).

Please find attached the Articles of Revocation Dissolution for the previous erroneous filing of Revocation of Only Quality Service by Tony, Inc. and other related items.


