1.- MR. GUSTAVO A. RUIZ HAS RESIGNED AS PRESIDENT AND MRS. YANHI

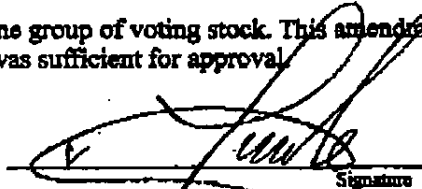
M. PERDOMO HAS BEEN APPOINTED IN HIS PLACE.
