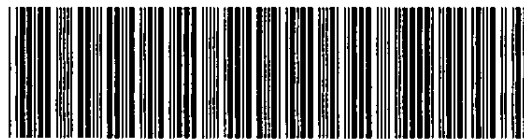

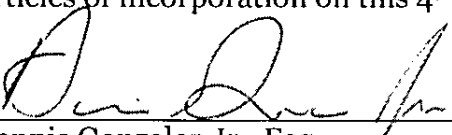
**ARTICLE VII.**

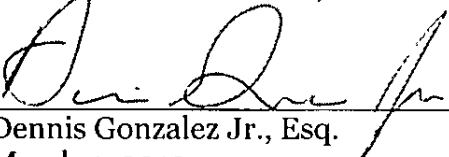
