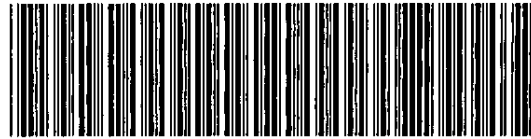

Name of Corporation

Brannan, Moore and Associates, Inc.

ARTICLE II
Business of Corporation

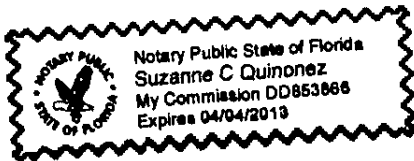
