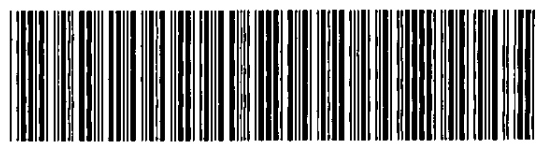



Under the provisions of Section 607.0124, Florida Statutes, this Corporation adopts the following Articles of Correction to its Articles of Incorporation:

FIRST:

These Articles of Correction correct information in the Articles of Incorporation, filed March 15, 2012. The Document number is P12000026206.

SECOND:

Article V, Section 5.1 of the Articles of Incorporation incorrectly identifies the principal office of the corporation at 245 Riverside Avenue, Suite 150, Jacksonville, FL 322202

THIRD:

Article V, Section 5.1 of the Articles of Incorporation should identify the principal office of the corporation as being at 400 Huckleberry Trail, Jacksonville, FL 32259.

FOURTH:

Article VII, Section 7.2 is incorrectly numbered and incorrectly identifies the President as Howard A. Caplan. Article VII Section 7.3 is incorrectly numbered.

FIFTH:

Article VII, Section 7.2 should be numbered 7.1 and identify Sean Orr as President, Secretary, and Treasurer. Article VII Section 7.3 should be numbered 7.2.

These Articles of Correction were adopted by the incorporator prior to the organization meeting of the Corporation.
