ARTICLES OF INCORPORATION

OF

AIRO INDUSTRIES, INC.

The Undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME.

The name of this corporation is AIRO INDUSTRIES, INC.
