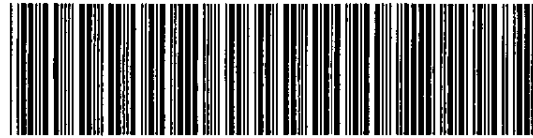

**ARTICLES OF INCORPORATION**

**OF**

The Undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I. CORPORATE NAME.**

The name of this corporation is **AIRO INDUSTRIES, INC.**

**ARTICLE II. PRINCIPAL OFFICE.**

The principal place of business and mailing address of this corporation is 2837 Fowler Street, Fort Myers, Florida, 33901.

**ARTICLE III. DURATION**

The corporation shall have a perpetual existence, except that the same may be dissolved as provided by law.
