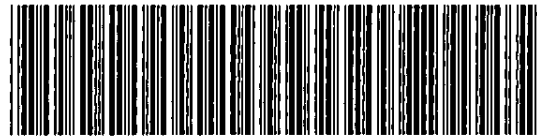

ARTICLE I - NAME

The name of this corporation is Jean Cubero, Insurance Services, Inc.

ARTICLE II - PRINCIPAL OFFICE
