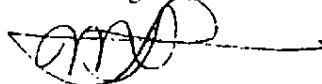

These Articles of Dissolution are filed pursuant to Section 607.1403 of the Florida Business Corporation Act, and provide as follows:

1. The name of the corporation is BRECKENRIDGE DEVELOPMENT, INC. (the "Corporation").
2. The Corporation was formed in the State of Florida on March 22, 2012, under Charter No. P12000028114.
