I, the undersigned subscriber to these Articles of Incorporation, natural persons Competent to contract, hereby form of Corporation under the Laws of the State of Florida.

ARTICLE I- NAME OF CORPORATION

The Name of the Corporation shall be:

ARTICLE II- GENERAL NATURE OF THE BUSINESS:

The General nature of the business and the object and purpose to be transacted and carried on are:

To conduct any and all business not prohibited by the laws of the United States and State of Florida.
