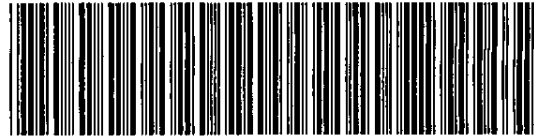


In case of any voluntary or involuntary liquidation, dissolution or winding up this corporation, the assets of the corporation will be paid and distributed accordingly to the shareholder.
