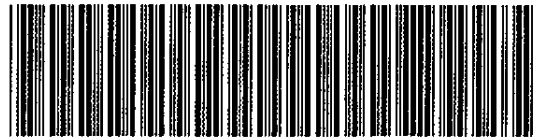



ARTICLE ONE

The name of the corporation is Richardson Kleiber Walter Kleiber Button Management, Inc.

The period of its duration is perpetual.
