ARTICLE XI - AMENDMENT

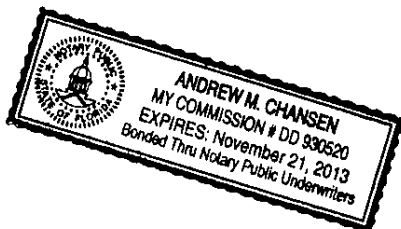
