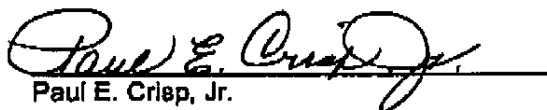

The undersigned incorporator has executed these Articles of Incorporation to establish a corporation (the "Corporation") under the Florida Business Corporation Act (Chapter 607, Florida Statutes).

1. Name. The name of the Corporation is:

Crisp Manufacturing Co., Inc.

2. Principal Office and Mailing Address. The street and mailing address of the principal office of the Corporation is:

3. Authorized Shares. The Corporation is authorized to issue a total of 500 shares of common stock having a par value of \$10.00 per share. Of those 500 shares, the Corporation is authorized to issue 50 shares of Class A Voting common stock and 450 shares of Class B Non-Voting common stock. Except as otherwise provided in this Corporation's articles of incorporation, the rights, privileges, and preferences of the Class A Voting common stock and the Class B Non-Voting common stock shall be identical, except that all voting rights of common stock shall be vested in the shares of Class A Voting common stock, entitling each share of issued and outstanding Class A Voting common stock to one vote upon any matter upon which the shareholders are entitled to vote. The shares of the Class B Non-Voting common stock shall have no voting rights or privileges. No share shall be issued except upon payment to the Corporation of the par value of the share in cash or other consideration permitted by law as payment for shares.

4. Bylaws. The bylaws of the Corporation shall be adopted by the incorporator or the board of directors. The power to alter, amend or repeal any bylaw shall be vested in the shareholders, except to the extent delegated by the shareholders to the board of directors.
