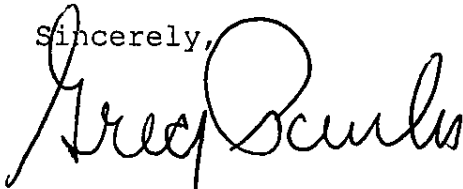

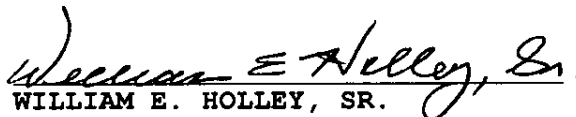
#### ARTICLE XIV - AMENDMENTS

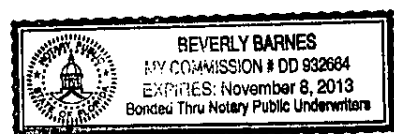

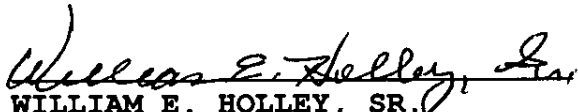
