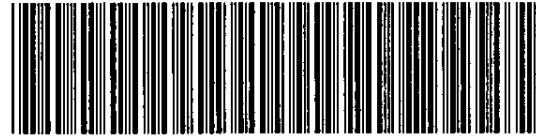



The undersigned, for the purpose of forming a for-profit under the laws of the state of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of the Incorporation shall be **JRTB Consulting, INC.** (hereinafter called the "INC").


