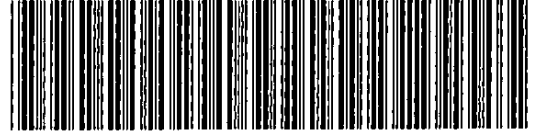

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be SOUND FOUNDATION REAL ESTATE, INC.
(the "Corporation")..

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office, and the mailing address, of this Corporation shall be located at 2603 N.W. 13th Street, PMB 301, Gainesville, Florida 32609.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is Ten Thousand (10,000) shares of common stock having a par value of Zero and 01/100 Dollars (\$0.01) per share.

**ARTICLE IV - INITIAL REGISTERED OFFICE
AND REGISTERED AGENT**

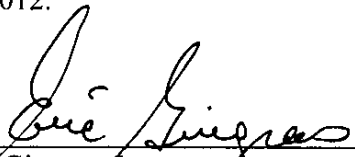
ARTICLE VIII - INDEMNIFICATION
